Brigid,

As requested, I received this from Nate Fredericks at Simon Operations Services (SOS) on the Warren Septic control panel. I also talked with Dave Mead from Advanced Onsite Services (a sub-contractor used by SOS). He stated if this system goes down it will take 2-3 weeks to receive and install the replacement controls. He said the recommended controls will be compatible with the controls for the Town of Warren. This is beneficial in that Warren keeps spare parts in stock for their systems and if need be they could be a resource to keep the school system up and running in the future should we have a problem. He did mention that the existing controls are outdated and if we tried to replicate these it would take a few months to build a new control board at more than \$15,000.

This is certainly a high priority for this next construction season.

Advanced Onsite Services did a lot of the work through the years. Dave Mead and Jared Wiley are the contacts for the company 802-338-0698. I asked them for data last week. Maybe if you call Dave Mead he could provide some more info.

Circa 2008-2010 Lightning Strikes

System Representatives: Andreas Lehner and Lloyd, and Simon Operation Services Contractor: Waitsfield Telecom, Wastewater Technologies Inc (Now: Advanced Onsite Services, AOS)

There were two, separate lightning strikes through the panel that caused the circuit logic board to fault and need replacement. At the time the new board took a week to arrive and the reinstall. The septic tank was pumped.

Circa 2012 Circuit logic board - Phone line/DSL filter malfunction

System Representatives: Wendy Cobb and Lloyd, and Simon Operation Services

Contractor: Waitsfield Telecom, AOS

The board's phone line/dsl filter had to be replaced after another electrical surge (lightning strike) went through the panel. This time the board did not need complete replacement. But there were multiple control panel components that needed replacement. Additionally, the phone line was replaced from the Pole to the Control Panel.

Circa Summer 2016 Control panel gasket and control panel alarm light socket replacement System Representatives: Beth Peterson and Lloyd and Simon Operation Services Contractor: AOS

After the spring annual inspection it was determined that the control panel gasket and alarm light socket components needed to be replaced. Both were replaced Summer 2016
